[origin: ES236889U] Pneumatic, of the type comprising a belt-shaped running surface and two side parts, each side part being composed of a side wall with a bead ring and a part of the base of the running surface, characterized in that the base of the running surface has the following characteristics: a) the base of the running surface develops as a ring that reaches to the center of the tire and, on the other side, joins intimately with the side wall; b) bands with the width of the ring are fastened to the ring contour in the center of the running surface; c) the width of the bands is approximately equal to the space of the bands between each other; d) in the part of the ring directed towards the surface, depths are arranged in which the bands of the second lateral part fit, during their assembly, so that the running surface shows, after assembly, approximately a smooth surface; e) at the end of the bands, a projection is provided in each case to fit the running surface. Der Luftreifen besteht aus 2 Seitenteilen und einer Gürtelartigen Lauffläche. An jedem Seitenteil ist einer halbe Laufflächenunterlage angeformt; in der Laufflächenunterlage sind Bänder befestigt; die Bänder sind auf Lücken und kommen in Vertiefungen in der anderen Laufflächenunterlage zu liegen, so dass im zusammengebauten Zustand die Laufflächenunterlage eben ist. Die an den Enden der Bänder vorhandenen Wulste halten die Lauffläche fest.
