Abstract (en)

[origin: EP0017880A2] 1. A device for filling out a competition form, in particular for lotto- and toto-games, on which at least one play field is provided which is subdivided into a plurality of marking fields comprising - pin-shaped stamps (13), each of which is associated with a marking field (5') of the play field (3') and can be lowered onto the associated marking field (5') on the competition form, - a pressing piece (29) arranged above the stamps and resiliently supported on the upper part of the stamp guide and - a framed selection space provided between the pressing piece (29) and the top ends (37) of the stamps, within which it is decided with the aid of marking pieces (31, 58) which of the stamps (13) will be pressed down by the pressing piece (29), characterized by a stamp guide plate (11), - the thickness approximately corresponds to the length of the stamps, - through which extend vertical guide channels (15) for the stamps (13), - which is firmly anchored in the housing (17) of the device, - in which the stamps (13) are guided so as to be freely slidable, - above the underside (10) of which, located at the stamp space (53) receiving the competition form (1), is stretched a stamping colour cloth (51), on which the stamps (13) are bearing and - the top side of which constitutes the horizontal bottom (33) of the selection space comprising the marking pieces (31, 58).
