Abstract (en)
1. A lamp having at least two strip lamps disposed end to end as light sources in a lamp tube, electrically conductive intermediate compression springs being disposed between two respective contact ends, directed towards one another, of the strip lamps, characterized in that compression springs (5) abut against the respective outer electrically conductive contact ends (4) of the outer strip lamps (2) and the other ends of said compression springs abut against the respective other end of lamp bodies (6), that electrically non-conductive sleeves (9) are disposed as spacers and/or symmetry-holders around the cylinder circumferential surfaces (8) of the contact ends (4) of the strip lamps (2), that the lamps tube (3) has at least one light exit slot (10) extending in a longitudinal direction, and that the ends of the lamp tube (3) are each rotatably secured to the lamp bodies (6) for the purpose of turning the light exit slot (10) about the longitudinal axis of the lamp.

Abstract (de)
Die Erfindung betrifft eine Leuchte mit wenigstens einer Soffittenlampe (2), die als Lichtquellen in Reihe hintereinander in einem Leuchtenrohr (3) angeordnet sind. Diese Leuchte ergibt ein natürliches, warmes Licht und ist durch einfaches Auswechseln der dabei verwendeten Soffittenlampen sehr wartungsfreundlich. Vorzugsweise liegen an den jeweils äußeren, elektrisch leitenden Kontaktenden (4) der Soffittenlampen (2) Druckfedern (5) an.
