Abstract (en)

[origin: EP0065199A2] The connecting system, which is intended in particular to inhibit passage in order to protect endangered articles, consists of adjacent building blocks provided with dovetail-like locking contours as connecting means, which are connected firmly, but separably, together in such a way that the locking contours of neighbouring blocks engage with one another positively and provide, at least in one direction extending essentially perpendicular to a guiding axis which is common to two interacting locking contours, a connection between the neighbouring building blocks which is resistant to tensile forces. In the direction of the common guiding axis of the interacting locking contours, on the other hand, the building blocks are displaceable relative to one another and thereby separable. <IMAGE>
