[origin: EP0071213A2] 1. Laminated article for construction purposes containing at least one non-woven textile layer and a granular material, characterised in that a layer (5) of granular particles of building materials (6), such as sand, gravel, binder such as chalk, gypsum, cement or mixtures of these, is disposed and secured between an under-layer (3) and a covering layer (2), of which at least the one contains fibres or threads and which are needled together through the particle layer.
