Abstract (en)  
1. Venetian blind for light-permeable openings surrounded by a frame (40) and positioned in walls or roofs, with a group of elongated slats (8), which can be brought together and drawn apart again, which are interconnected in chain-like manner by means of collapsible strips, strings or the like (12) and which can be brought together by means of suitable pulling members (15), lateral members (3, 4) and an upper transverse member (2) being provided outside the slats (8) and in the vicinity of the upper transverse member (2), the venetian blind (1) is articulated to two pivot pins (43) so as to be pivotable about an axis at least approximately parallel to said transverse member (2), said pivot pins being arranged on the frame (40) surrounding the opening to be covered, characterized in that the pivot pins (43) in each case engage in the vicinity of the upper transverse member (2) in a bore of the associated lateral member (3, 4) and that the pivot pins (43) are in each case placed on a cover plate (45), which engages on a bearing block (47) or the like fixed to the frame (40).

Abstract (de)  
Bei der Jalousie (1) sind deren einzelne, kettenartig durch Tragschnüre miteinander verbundene Lamellen (8) mittels seitlich vorstehender Lagerzapfen (11) beiderseits in Richtung des Pfeiles (14) verschiebbar in aus Profilmaterial bestehenden Seitenholmen (3) und (4) gelagert. Ein zwangsweises Verschieben der Lamellen (8) wird dabei mit Hilfe von endlos um Umlenkrollen (16) und (17) herumgelegte Zugschnüre (15) bewirkt, die über die mittels einer Welle (18) wechselweise in beiden Richtungen in Umlauf zu versetzen sind.
