The use of amine salts of maleamic acids of the formula I see diagramm : EP0106234,P5,F2 where R**1 and R**2 are identical or different and each denotes alkyl or alkenyl of 8 to 18 carbon atoms, and R**3 is hydrogen, alkyl of 1 to 18 carbon atoms or alkenyl of 2 to 18 carbon atoms, as agents for inhibiting the corrosion of metal brought about by H₂S and CO₂ in water-in-oil emulsions, in admixture with amines of the formula II see diagramm : EP0106234,P5,F3 or amide acids of the formula III R**1 NH-CO-CH=CH-COOH R**1 , R**2 and R**3 having the above meanings, and the molar ratios of amine salt to amine and of amine salt to amide acid each being up to 1 : 2.
