[origin: EP0108032A2] In a control device for a gas-heated flow heater with a heat exchanger and a burner, which is fed by a fuel supply pipe which is provided with a valve and governed by a thermo-electric safety pilot, the valve (5) of the thermo-electric safety pilot (15, 13) connected to a pressure medium servo motor (53) which is connected to a pressure medium source (42) which is preferably designed as a pneumatic diaphragm pump (49).
