[origin: WO8401971A1] A waterless dip dye composition for non-textile and general-utility articles comprises an aromatic ester of the formula ArCOOR<sub>2</sub>, ArCOO-R<sub>1</sub>-OOCAr or (ArCOO)<sub>z</sub>-R<sub>3</sub>, wherein R<sub>1</sub> is alkylene of 2-8 carbon atoms or polyoxyalkylene of the formula -CrH<sub>2r</sub>(OCrH<sub>2r</sub>)<sub>s</sub>, in which r is 2 or 3 and s is 1 to 15; R<sub>2</sub> is substituted or unsubstituted alkyl or alkenyl of 8-30 carbon atoms; R<sub>3</sub> is the residue of a polyhydric alcohol having z hydroxyl groups; Ar is substituted or unsubstituted mono- or bicyclic aryl of up to 15 carbon atoms and z is 3-6, admixed with at least 0.5% by weight of a dyeing assistant agent and an organic colorant. A process for coloring non-textile and general-utility articles, fabricated from polyester, polyamide, polyurethane, acrylic, halogenated polyolefin or epoxy plastic, comprises exposing an article to the foregoing compositions, maintained at a temperature from about 100°C to the temperature at which the plastic degrades, for a time adequate to achieve the desired degree of coloration.
