[origin: WO8403222A1] Installation for the transport of tennis balls having at least one substantially vertical bouncing wall as well as a collector gutter for the balls and arranged at the foot of the wall. The covering (1) of the bouncing wall (2) is simply attached to a pair of parallel flanges (6, 6') of the frame and the lateral portions (8, 8') connecting the flanges (6, 6') move away from each other due to the pressure of the springs (7) which are arranged thereto.
