Abstract (en)  
[origin: EP0136496A2] A transport and/or storage process for waste, esp. chemical and/or radioactive waste, comprises prepg. a strongly thixotropic emulsion with low water content and adding the waste in (semi-) fluid or sludge form to the emulsion. Also claimed is an emulsion for use in the process, the emulsion contg. a resin (pref. an unsatd. polyester resin), a monomer (pref. an unsatd. monomer with an extremely high flame point) and a thixotropic agent.
