Abstract (en)

It has been found that a conveyor system can be lubricated with dilute [1.0×10^{-3} to 3×10^{-2} M] aqueous solutions of a partially neutralized mono phosphate ester of the formula: $\text{R}_n\text{P}(\text{O})_2\text{O}^-$ wherein n has a value 0 to 3 and R is a C12 to C20 saturated or partially unsaturated linear alkyl group, or a mixture of such groups. The use of a synergist such as a long-chain alcohol, a fatty-acid derived amine oxide, or urea improves the properties of the lubricant compositions.
