[origin: EP0143488A2] This invention is embodied with a plant (10) to form and for the heat treatment of rolled products in coils and compact wound bundles, which comprises cooling conveyor means (16), means (15) to form coils and means (14) to form wound bundles and which includes at least an initial section of the cooling conveyor (16) in momentary cooperation, which can be selected as required, with the means (15) to form coils and the means (14) to form wound bundles respectively, and includes at least one switching station (17).
