Abstract (en)

[origin: US4735845A] A safety binding of a boot on a ski, which comprises two lateral clamps (1) displaceably mounted under the effect of a resilient member between a closed service position, in which the clamps cooperate with the sole of the boot, and an open position. Each lateral clamp is pivoted at the end of an arm (12) on a pivot axle (14) perpendicular to the plan of the ski, said arm being itself pivotally mounted by its other end on an axle (13) perpendicular to said plan of the ski.
