#### Abstract (en)

[origin: EP0181044A2] A soil cultivating implement that is movable operatively over the ground in the direction (A) by a tractor or other operating vehicle comprises a row of power-drivable soil working members (3) that extends substantially horizontally perpendicular to the direction of travel (A) with each member (3) having at least one soil working tine (5) that projects downwardly into the soil that is to be cultivated. The implement has a frame portion (1) upon the top of which two support plates (21) have the leading ends of lower and upper links (22 and 23) connected to them by lower and upper horizontal pivots (24). The rear ends of the links are connected to upright arms (26) by releasable pivot pins (25 and 27) whose position relative to said arms (26) can be changed by entering them through chosen holes (29) in rows of those holes (29) formed through the upright arms (26). The links (22 and 23) and the arms (26) form parts of corresponding pivotable quadrilateral linkages (28) and the lower ends of the arms (26) carry a soil collecting member (56) which comprises a row of elongate tooth-like elements (49) whose position relative to one another and to the arms (26) are adjustable Spring-loaded latches (34) provided with operating handles (35) can be entered in chosen slots (37) to fix the angularity of the linkages (28) for as long as may be required. The construction allows the level, inclination to the vertical and position with respect to the direction of travel (A) of the soil collecting member (56) to be adjusted to a very large extend thus enabling said member (56) to function in a substantially optimum manner in virtually all of the many and varied operating circumstances of the implement.
