Abstract (en)

[origin: US4712168A] A spotlight bracket for a false ceiling or false wall constituted by a stretched sheet hooked, along its edges, to a support fixed to the wall or to the ceiling, comprises two parts adjustable with respect to each other, namely an upper part fixed to the ceiling and a lower part adjustable in height and in inclination with respect to the fixed upper part. The upper part, in the form of a downwardly open fork-joint, comprises an upper horizontal web fixed to the ceiling or wall. This web is pierced with a hole for the passage of an electric cable and it is fast, at its two ends, with two vertical, downwardly extending arms. The adjustable lower part, which is also in the form of a fork-joint open upwardly, comprises a lower horizontal base plate fast with two opposite vertical arms extending upwardly and which tighten on the arms of the fixed upper fork-joint.

Abstract (fr)

Un faux plafond ou faux mur, constitué par une nappe tendue accrochée, le long de ses bords, à un support fixé au mur ou au plafond, peut comprendre, en divers endroits, des spots d'éclairage. Pour faciliter l'installation de ces spots d'éclairage chacun de ceux-ci est monté dans une chaise de spot comprenant deux parties réglables l'une à rapport à l'autre, à savoir une partie supérieure (4) fixée au plafond (2) et une partie inférieure (5) qui est réglable en hauteur et en inclinaison par rapport à la partie supérieure fixe (4).
