Abstract (en)

[origin: EP0232872A2] The invention relates to a coin-operated gaming machine with a numerical data display and, where appropriate, an electronic win determination device, a coin insertion device and a coin discharge device. Formed in the operating-side front plate 3 of a housing 2 are setting keys 4 for selecting a symbol, the coin insertion device 5, the coin discharge device 6 and a dispensing orifice 7 for a gaming ticket. In the housing 2, the coin-collecting container 43 on the machine is designed as a discharge device 30 which is connected to a counter 35 and to an on/off switch 23. This can be designed, for example, as a key-operated switch, if appropriate with a code (Fig. 1) <IMAGE>
