Abstract (en)
[origin: EP0261320A2] The pistol has a pistol casing (10), a valve (7), with a sealing element (25), inside the pistol casing (10), two tubular sections (14, 15) inside the pistol casing (10), one serving to deliver a liquid to the valve (17) and one carrying liquid away from the valve (17), and a hand lever (11) freely supported inside the pistol casing (10) and acting on the sealing element (25) of the valve (17), in which the two tubular sections (14, 15) form an angle in relation to one another, preferably an obtuse angle, can be considerably simplified in design and at the same time its safety and handling improved by making the two tubular sections (14, 15) in one piece, that is preferably as a continuous angled tube (13), and locating the valve (17) inside one tubular section (14 or 15), preferably in the tubular section (14) serving to deliver the liquid and giving one tubular section (14 or 15) an aperture (23) for the passage of an actuating element (24) for the sealing element (25) of the valve (17). <IMAGE>
