Abstract (en)  
The retractable barrier, intended to prevent access to roads or passages, consists of a flexible element (16) stretched across the path between two posts (1)(2). In a rest position, the flexible element (16) is wound onto a drum (10), housed inside one (1) of the posts and driven by a spring or by an electric motor; when set up as an obstacle, the unwound flexible element (16) is attached to the other post (2). This attachment (14) is lockable (13), and a lockable (12) cover (11) protects a means (9) for immobilising the drum (10). <IMAGE>

Abstract (fr)  
La barrière escamotable, destinée à interdire l'accès de routes ou passages, est constituée d'un élément souple (16) tendu en travers de la voie entre deux poteaux (1)(2). En position de repos l'élément souple (16) est enroulé sur un tambour (10), logé à l'intérieur de l'un (1) des poteaux et entraîné par un ressort ou par un moteur électrique ; en position d'obstacle l'élément souple (16) déroulé est accroché à l'autre poteau (2). Cet accrochage (14) est verrouillable (13), et un couvercle (11) verrouillable (12) défend un moyen de blocage (9) du tambour (10).
