[origin: WO8706579A1] Dihydropyridine of formula (I), in which R6 and R7 represent jointly, and inclusively of the nitrogen atom to which both are bound, a residue of formula (II), wherein A is -CH2-C(R8)R9-CH2-; R8 is aryl and R9 is aryl, whereby aryl stands for a ring of formula (III) in which R10 and R11 are the same or different and signify hydrogen, alkyl, alkoxy, halogen, hydroxy or trifluoromethyl and wherein either E is alkylene, R2 amino and R3 alkyl or alkoxyalkyl, or E is A1-O-A2, R2 is hydrogen, alkyl or alkoxyalkyl and R3 is hydrogen, alkyl or alkoxyalkyl, whereby A1 is alkylene and A2 alkylene or alkyleneoxy-alkylene, and the salts of these compounds, as well as process for their production and their use as medicaments.

Sont également décrits les sels de ces composés, ainsi qu'un procédé pour leur production et leur utilisation comme médicaments.
