[origin: EP0316010A2] An image forming apparatus includes image forming device for forming a toner image on a recording material, the image forming device including electrical discharger (2), fixing device (13) for fixing the toner image with heat, and air discharging device (24) for discharging air between said fixing device (13) and discharger (2) in said apparatus, and controller for controlling the discharging device (24) in accordance with a heated state of said fixing device (13).
