Abstract (en)

The invention relates to a releasable binding system for a snow board, such as, in particular, a monoski. The binding system comprises two individual binding members 2, 3, each member having elastic retention means intended to hold one of the feet of the user. Means 40, 41 connect each individual binding member 2, 3 to the retention means of the other binding member 3, 2 so that, when a boot is released, the retention means of the other binding member are disarmed, thus permitting the release of the other boot. <IMAGE>

Abstract (fr)

L'invention concerne un ensemble de fixations déclenchables pour planche de glisse, telle que notamment un surf (1). L'ensemble de fixations comprend deux organes de fixations individuels (2, 3), chaque organe présentant des moyens de retenue élastique destinés à retenir l'un des pieds de l'utilisateur. Des moyens (40, 41) relient chaque organe individuel de fixation (2, 3) aux moyens de retenue de l'autre organe de fixation (3, 2) de façon que, lorsqu'une chaussure est relâchée, les moyens de retenue de l'autre organe de fixation sont désarmés, permettant ainsi la libération de l'autre chaussure.
