Abstract (en)
[origin: WO8808402A1] The present invention relates to a method for removing and transferring refuse from serving trays (9) which on conveyor belts (2) are carried past different stations for removing dirty dishes, removing refuse and washing the trays. According to the invention a vacuum is produced in a suction nozzle (10) provided immediately adjacent the path along which the trays (9) are conveyed, and the refuse is transferred through a transfer duct (6) which is connected to the nozzle and through which the vacuum is produced at the nozzle. The invention also relates to an installation for performing the method.

Abstract (fr)
Procédé permettant de retirer et de transférer des déchets à partir de plateaux-repas (9) portés sur des bandes transporteuses (2), devant et au-delà de différents postes afin de retirer les assiettes sales, d'enlever les déchets et de laver les plateaux. D'après l'invention on produit une aspiration dans une suceuse (10) adjacente située à proximité immédiate du chemin que suivent les plateaux (9), les déchets sont transférés à travers un conduit de transfert (6) relié à la suceuse et à travers lequel on produit une aspiration au niveau de la suceuse. L'invention se rapporte également à une installation permettant de mettre en oeuvre le procédé.
