Abstract (en)

The method comprises substantially the forming of a reusable formwork (9) of the upper part of the slab and the mounting, upside down, of the assembly of truss elements (1) connected between each other and to the support sections (2), the truss elements (1) being mounted transversally with respect to the sections (2), within said formwork, the support sections (2) being maintained so as to present substantially their connection part (3) to the truss elements (1) in the formwork volume (9) to be filled with concrete (4).

Abstract (fr)

Le procédé consiste essentiellement à réaliser un coffrage réutilisable (9) de la partie supérieure de la dalle et à monter, retourné, l'ensemble des éléments d'armature (1) reliés entre eux et aux profilés de support (2), les éléments d'armature (1) étant montés transversalement par rapport aux profilés (2), dans ledit coffrage, les profilés de support (2) étant maintenus de manière à présenter essentiellement leur partie de connexion (3) aux armatures (1) dans le volume du coffrage (9) à remplir de béton (4).
