[origin: WO9011227A1] In a crate made up of two identical parts (1, 1'), especially to contain beverage bottles, it is proposed to join the parts of the crate together by vertically extending connecting strips (19, 21) which, with the two parts of the crate assembled, cause said parts to engage with each other via hook-shaped members which may be mutually separated by moving them sideways, and by securing the assembled parts of the crate by locking components preventing the sideways movement of the parts.
