[origin: EP0392482A2] Roving packages are fed into the creel of a spinning frame by movements along a path at right angle to the machine longitudinal axis and are moved out of the creel by movement along another path at right angles to the machine longitudinal axis, the two paths being joined by a path extending along the machine.
