[origin: JPH0340853A] PURPOSE: To produce a mineral fiber mat having from low density to high density by using an apparatus comprising a fiber producing machine, an accumulating machine and a conveyor belt and accumulating mineral fibers drawn out by a gas on a transferring conveyor belt. CONSTITUTION: This mineral fibers mat having a uniform thickness and excellent mechanical strength without any polymerization of a binder resin in accumulating operation is obtained by accumulating mineral fibers (preferably glass fibers) drawn out from spinnerets in a fiber producing machine 20 by a gas flow on a transferring gas permeable conveyor belt 26 while separating the gas from the fibers between drums 21 having gas-permeable surfaces and a vacuum sucking chamber inside.
