Abstract (en)  
A grease composition for constant velocity joints comprises a base grease comprising a mineral oil and an urea compound, to which are added the following compounds: (1) 0.5 - 5 % by weight, based on the grease composition, of a molybdenum dithiocarbamate compound and 0.5 - 5 % by weight, based on the grease composition, of a molybdenum dithiophosphate compound as organo-molybdenum compounds, (2) 0.5 - 10 % by weight, based on the grease composition, of zinc dithiophosphate compound as an extreme pressure agent, and (3) 0.5 - 60 % by weight, based on the grease composition, of a copolymer of ethylene and branched alpha -olefin. <IMAGE>
