[origin: WO9109875A1] Disclosed are (1) a monoclonal antibody which immuno-neutralizes the activity of a bFGF protein and highly sensitively combines with the bFGF protein; (2) a cloned hybridoma for (1); (3) a method for producing the cloned hybridoma (2); (4) a method for producing the monoclonal (1); (5) a method for purifying the bFGF protein, which comprises using the monoclonal antibody (1); and (6) a method for detecting or determining the bFGF protein, which comprises using the monoclonal antibody (1).
