Abstract (en)  
A game tool comprising a game board (2), game pieces (I), and a preservation member (30) for temporarily preserving a fighting condition, in which the game pieces (I) are optionally arranged on the game board (2), in the fighting condition such that it is capable of being reopened at any time, if a fighting is temporarily interrupted. Further, a Go set (E) having numbered black stones (I) and white stones (I), and a pair of Go vessels (II; I2) for receiving therein the stones (I) in number order can preserve game procedure without having to take a record of a game of Go. The game tool comprising a magnet-attractable metal plate (2), a transparent sheet, a game form and magnet playing-pieces (I) are optimum as teaching materials for Go. In a Go set in which longitudinal and lateral lines on a Go board (2) are formed respectively by metal lines, and magnetic Go stones (I) are used which are light in weight, it is possible to accurately place the stones (I) respectively at the points of intersection between the lines. <IMAGE>
