Detergent compositions are disclosed, comprising a polyhydroxy fatty acid amide surfactant of the formula: <CHEM> wherein R<1> is H, C1-C4 hydrocarbyl, 2-hydroxy ethyl, 2-hydroxy propyl or a mixture thereof, R<2> is C5-C31 hydrocarbyl and Z is a polyhydroxyhydrocarbyl having a linear hydrocarbyl chain with at least 3 hydroxyls connected directly to said chain, or alkoxyated derivatives thereof and a clay-softening system. a po
