[origin: WO9203458A1] The present invention relates to a DNA segment encoding a recombinant non-A, non-B hepatitis structural protein or fusion protein and a recombinant DNA (rDNA) molecule capable of expressing either protein. Cells transformed with the rDNA, methods for producing the proteins in addition to compositions containing the proteins, and their use in diagnostic methods and systems, and in vaccines are also described.
