Abstract (en)

This method for lubrication and sealing of cork stoppers is based on a well balanced synergic association of non toxic chemically inert products suitable for foodstuffs, consisting of a silicone based fluid, paraffin, a paraffin oxy-stabilizer, amorphous colloidal silica gel to stabilize the silicone-paraffin compound, a metal salt stearate having an antistick-slip action, to which pigments and plasticizers may be added. This association can be obtained by hot or cold process to form a cream to be cold applied to the cork stoppers.
