[origin: EP0570878A1] A reproducing device for short films and/or commercials and/or quiz questions, in particular in amusement centres, contains at least one projection screen 2 for presenting short films and/or commercials and/or at least one quiz question that is to be faded in, a projection device 4 for projecting the short films and/or the commercials and/or the quiz question or questions that is/are to be faded in, an acoustic device 5 for reproducing the scoring/musical setting of the short film and/or the commercials and/or the quiz question or questions, a storage device 6 for storing the short films and/or the commercials and storing at least one quiz question that is to be faded in optically and/or acoustically into or between the short films and/or commercials and for storing the correct answer word, a device 10 which has a keyboard 11 for inputting answer words to the quiz question and an additional device 9 for comparing the input answer word with the stored correct answer word, a further device 12 which has a programmable memory 13 for individual consumer goods and/or services on offer and/or displays of the addresses of their suppliers and has a display 14, which device 12 is driven by the device 10 after the correct answer word has been input into the latter, subdivision of the display 14 into panels (fields) 15a, 15b, ... for representing the individual consumer goods and/or services and/or displays of the addresses of the suppliers, and a printer 16 for printing out the selected supplier as a document for further items of information to be obtained from the supplier. <IMAGE>
