Abstract (en)  
Suspended ceiling made up of parallel and equidistant longitudinal support profiles (1) supporting trays (2) which can be moved in terms of translation and each be tilted by pivoting about an axis perpendicular to the said supports (1), the said trays (2) being rectangular panels (2) including, at each corner, a lock (11), the bolt (12) of which is held by a return mechanism (15) in the out position in the face parallel to the support (1), characterised in that the support profiles (1) include two lateral slideways (6b) of the same axis as the profile (1) in which the connections with the panels (2) are provided via members intended to facilitate the sliding of the panels (2) when flat or tilted. <IMAGE>

Plafond suspendu constitué de profils supports (1) longitudinaux parallèles et équidistants supportant des bacs (2) déplaçables en translation et basculables chacun par pivotement autour d'un axe perpendiculaire auxdits supports (1), lesdits bacs (2) étant des panneaux rectangulaires (2) comportant à chaque coin un verrou (11) dont le pêne (12) est maintenu par un mécanisme de rappel (15) en position sortie dans la face parallèle au support (1), caractérisé en ce que les profils supports (1) comportent deux glissières (6b) latérales de même axe que le profil (1) dans lesquelles les liaisons avec les panneaux (2) sont assurées par l'intermédiaire d'organes destinés à faciliter le coulissement des panneaux (2) à plat ou basculés. <IMAGE>
