Abstract (en)  
[origin: WO9325175A1] A sealed dissolving liquid container (1) and a bottomed cylindrical case (3) having an air vent through bore (8) are connected together via a joint member (4), and a cylindrical drug bottle fixing jig (13) into which a drug vial (2) is inserted with its mouth portion facing downward is movably set in the case (3), a sealed space being thus formed between the drug vial fixing jig (13) and a bottom portion of the case (3). The drug bottle (2) and dissolving liquid container (1) are allowed to communicate with each other quickly by a double ended needle (16) with the sealed condition retained. This medical container enables a drug dissolving operation to be carried out speedily and aseptically during a drip treatment, requires little storage space, and has a smaller number of parts and a smaller total length.
