[origin: EP0599164A2] Holder for cigarettes for the checkout area of a retail shop, having a plurality of shafts, each receiving a multiplicity of cigarette packets of one brand, a device accessible to the customer and intended for the selection of one of the shafts, and a device for guiding a cigarette packet from the shaft selected by the customer into the access region of the cashier occupying the checkout area, thus effectively preventing theft of cigarette packets. <IMAGE>
