The invention relates to carboxylic acid derivatives of the general formula A - B - C - D - E - COOR<sub>a</sub>, (I) in which A to E and R<sub>a</sub> are defined as in Claim 1, in particular compounds of the formula (II), <IMAGE> to their tautomers, their stereoisomers, including their mixtures, and to their salts, in particular to their physiologically tolerated salts with inorganic or organic acids or bases, which have valuable pharmacological properties, preferably aggregation-inhibiting effects, to drugs (medicaments, pharmaceuticals) containing these compounds, and to processes for their preparation.
