Abstract (en)
[origin: EP0604806A2] A phospholipid composition which, besides conventional ingredients, contains at least 20% by weight of phosphatidylcholine, at least 20% by weight of N-acylphosphatidylethanolamine and less than 3% by weight of phosphatidylethanolamine is described. A process for the production of the phospholipid composition uses acylated crude lecithin as starting material and treats this acylated crude lecithin with methanol. After removal of a residue resulting from this, the phospholipid composition is isolated from the methanol extract.
