Abstract (en)

A climbing console (3) which can be suspended on a wall (1) exhibits a frame (4) and a hook (5) which is mounted displaceably in the frame (4) and can be fixed in a wall recess (2). The hook (5) can be braced and/or released with the transverse wedge (6) which can be displaced parallel to the wall (1). A carriage (8) mounted displaceably on the frame (4, 4c) can be fixed by means of an arresting wedge (9) which can move in the displacement direction. The arresting wedge (9) can be clamped with respect to a transverse wedge (10) which is provided on the carriage and can be displaced parallel to the wall (1). <IMAGE>

Abstract (de)

Eine an einer Wand (1) einhängbare Kletterkonsole (3) weist einen Rahmen (4) auf und einen im Rahmen (4) verschiebbar gelagerten, in einer Wandaussparung (2) fixierbaren Haken (5). Der Haken (5) ist mit einem parallel zur Wand (1) verschiebbaren Querkeil (6) ver- bzw. entspannbar. Ein am Rahmen (4, 4c) verschiebbar gelagerter Schlitten (8) ist mit einem in Verschiebungsrichtung beweglichen Arretierungskeil (9) fixierbar. Der Arretierungskeil (9) ist gegen einen am Schlitten vorgesehenen, parallel zur Wand (1) verschiebbaren Querkeil (10) verklemmbar. <IMAGE>
