Abstract (en)

A lubricant composition, in particular for the lubrication of transport belts in the food and beverages industry, contains at least one amine compound of the general formula (I) > R<1>-(NH-CH₂-CH₂-CH₂)_x-NH₂ wherein x is a positive integer from 2 to 4 and R<1> is a linear or branched alkyl group having 8 to 22 C atoms, which group can be monounsaturated or polyunsaturated, and may contain a diluent and/or auxiliaries or additives.
