[origin: CA2122574A1] The invention relates to an information carrier for clamping onto rods (S), particularly clothes rods or the like, having a holding clamp which, by its two first arms of a resilient material, forms a substantially C-shaped clamping jaw to receive the rod (S), having at least one second arm which extends into the clamping jaw and which, together with a partial region of its side surface, forms a holding region for resilient action on the rod (S), and it proposes, in order to achieve a greater field of use, that the second arm (3) be formed resilient on the free end (2') of the first arm (2).
