[origin: WO9316750A1] A tube holding clamp (14) in the form of a cylinder open at both ends is attached at one end to a connection (16) which is attached to an adhesive member for attachment to the nose of a patient. The cylinder is slit (32) along its length to permit the tube (18) free entry and to resiliently hold the tube. The connecting member (16) is angular to hold the clamp forward of and in line with the nostrils.
