Abstract (en)
The invention relates to a cutting machine, especially a cutting machine which can be used for cutting cheese and/or meat. In order to improve maintenance, especially with regard to hygienic criteria, and to make it easy to operate the cutting machine, at least one region, which comes into contact with the material to be cut, of the cutting machine is provided with a surface structure which reduces the amount of adhesion between the said region and the material to be cut.
