Date Aug. 18, 1994A process for the manufacture of a material for making a wind musical instrument and for making the instrument includes the steps of providing a wood powder, incorporating into the powder fibers chosen to adjust the modulus of elasticity of the mixture to the desired value for the instrument, placing the mixture into a heated mold to melt the natural resins in the wood while maintaining the mixture under pressure between 50x105 Pa and 700x105 Pa, and cooling the mixture under the pressure.
