Abstract (en)

[origin: WO9419437A1] A composition of matter useful in lubricating oil for reducing friction in an internal combustion engine, said complex comprising the reaction product of alkoxylated amine, acid and adenine and having formula (I), wherein Z is derived from either a hydrocarbolsalicylic acid, trithiocyanuric acid, a hydrocarbulsulfonic acid, a dihydrocarbyldithiophosphoric acid or a dihydrocarbyldithiobenzoic acid and wherein R is a hydrocarbly group of 2 to 22 carbon atoms, R<1> is hydrogen or a hydrocarbly group of 1 to 20 carbon atoms, x and y are each independently integers of from 1 to 15 with the proviso that the sum of x + y is from 2 to 20, and a, b and c are independent numbers from 1.0 to 3.0 wherein the ratios of a:b, a:c and b:c range from 1.0:3.0 to 3.0:1.0.
