[origin: WO9421806A1] A method is disclosed for the prevention or treatment of a viral infection comprising administering to a subject an effective amount of a delivery system comprising a vector effective to express in a cell susceptible to infection by the virus a gene encoding an agent which is effective, directly or indirectly, to prevent, eliminate or attenuate the infection, wherein the gene is subject to control between an operative state and an inoperative state in the cell through factors specifically associated with the virus and the cell. The method of the invention allows the effective regulation of gene products in target cells.
