Abstract (en)

[origin: WO9208388A1] A method is to be provided for a stick (14) of deodorant, adhesive, lipstick, releasing agent, shaving soap or colour pen, for example, optionally closable by a cap and surrounded by a casing (15) open at at least one end, with a piston (5, 11, 19) movable axially longitudinally along the casing (15) for dispensing a preferably brushable compound inside the casing, which allows the essential, non-consumable parts of the stick (14) to be repeatedly re-used. This is achieved by means of a refill (1, 1a, 1b, 1c, 1d, 1e) which consists essentially of a moulding (2) of the preferably brushable compound (23) shaped to fit the free internal volume and internal shape of the casing (15).
