Abstract (en)

[origin: EP0703008A2] The machining or processing system is particularly for painting an item such as a bumper (1), which consists of main (2) and ornamental (3) sections. These are first detachably secured together, at a distance from each other. They are then machined or processed simultaneously, being finally and permanently secured together in a subsequent operation. They can be detached from each other after the first operation and suspended from a holder (7) for painting etc.. One or more locking components (6) can be provided, detachably holding the sections apart. One end of the locking component can be secured to one section, while the free end of an arm on it passes through an opening in the other section.
