## Abstract (en)

The ventilation comprises a compressible sealed chamber (1) in a flexible material constituted by a container with a cover. The cover consists of membranes forming non return valves allowing inlet and exhaust of air into the container in a single flow direction. The cover has a groove in its periphery into which the upper edge of the container is housed and sealed. The compressible chamber is encased in an inner sole (14) which has on one face a network of air circulation channels (15) and holes (16). The channels communicate with the compressible chamber and the holes connect the channels to the internal sole opposite face. The container has at one end a flexible sloping tab (2') which lies on the wearing sole (20) and acts as a spring between this sole's upper surface and the inner sole lower face.

## Abstract (fr)

L'invention concerne un dispositif de ventilation pour un article chaussant de type sport ou ville. L'invention consiste en ce qu'il comporte une chambre compressible (1) en matériau souple et étanche constitué d'un réservoir (2) muni d'un couvercle (3), ledit couvercle (3) comportant des membranes formant clapet anti-retour (10, 11) permettant l'entrée et l'évacuation d'air dans le réservoir (1) selon un sens unique de circulation, et une semelle intérieure (14) sur laquelle la chambre compressible (1) est encastrable, ladite semelle (14) comportant sur une face un réseau de canaux de circulation d'air (15) en communication avec la chambre compressible (1) et étant munie de perforations (16) faisant communiquer lesdits canaux (15) avec la face opposée de la semelle intérieure (14). <IMAGE>
